The Metropolitan Opportunity Unit seeks to provide low-income people better access to jobs and other opportunities for upward mobility by supporting regional planning efforts, transportation investments, and housing development policies and practices that alleviate poverty and reduce its concentration within metropolitan areas. Previous to taking this position, Mac administered a program that focused on using homeownership to build assets for low-income families and their communities. That work centered on improving housing and housing finance markets to increase the chances that low-income homeowners succeeded in building wealth. Before joining Ford, Mac worked as a Senior Research Associate at the Center for Urban and Regional Studies at the University of North Carolina at Chapel Hill. From 2006 to 2008, he managed the Integer Group for Spain, an educational group consisting of more than 15 private and semi-private centres in Spain and more than 1,500 employees.

In the year 2002, he launched The Fundación Carolina and Santander Bank's LIDER Grants Programme, a project he directed for six years together with the President Andrés Pastrana. CEO & Managing Director, Stavros Niarchos Foundation Cultural Center A.E.

Ioannis Trohopoulos, 52, was born and raised in Veria, Greece, and was Director of the Veria Central Public Library from 1990 to 2012. From 1991 to 1996, he was also a lecturer on Library Automation and Management at the Library School of the Technical University of Thessaloniki.

From 1994 to 2004 he was the national coordinator for six EU projects, namely the MOBILE, PLDP, Publica, ISTAR, PULMAN, and CALIMERA projects. From 2004 to 2007 he coordinated

the Light Project, which was funded under Interreg III C East. From 2007 to 2011 he managed the European projects ENTITLE and UNTOLD, both funded under Grudvtiq programs, and the EDLocal and AccessIT EU projects, which focus on the development of digital libraries. In August 2010, during the IFLA conference in Gothenburg, Sweden, he received the Gates Foundation's annual *Access to Learning Award* on behalf of the Veria Central Public Library.

In 2011, with support from the Stavros Niarchos Foundation, he created and began implementing a highly original nationwide program titled *Future Library*. The program began with a feasibility study on the state and needs of municipal and public libraries across Greece and continues with the implementation of targeted actions to selected libraries so that they improve their operations and public programs. The overall aim of the program is to help libraries acquire the role of civic centers within their respected communities.

Ioannis Trohopoulos holds a Law Degree (1982) from the School of Law of the University of Thessaloniki.

Sam Tsemberis CEO, Pathways to Housing

Sam Tsemberis, Ph.D., serves as the CEO of Pathways to Housing, an organization he founded in 1992 based on the belief that housing is a basic human right. Pathways developed the Housing First model that provides immediate access to permanent housing for individuals who are homeless and who have psychiatric disabilities and multiple cooccurring conditions such as addiction and health problems. The Pathways' Housing First program has been successfully replicated across the United States, Canada, Europe and Australia. There is substantial research evidence documenting its effectiveness the program is endorsed by the United Sates Interagency Council on the Homeless and is listed in the Substance Abuse and Mental Health Administration's National Registry of Evidence Based Additionally, the program has received recognition and numerous awards including the American Psychiatric Association's Gold Award for excellence in community mental health. Dr. Tsemberis is a clinical-community psychologist and is on the faculty of the Department of Psychiatry at Columbia University Medical Center. He has received recognition and numerous awards for his commitment, innovation and advocacy to ending homelessness for people with mental illness and addiction. He currently serves as principal research investigator for several federally funded studies of homelessness and has published numerous articles and book chapters on these topics. Last year, Hazelden Publishers, published his book entitled Housing First: The Pathways Model to End Homelessness for People with Mental Illness and Addiction.

Ivan Vejvoda

Vice President for Programs, German Marshall Fund of the United States

Ivan Vejvoda is Vice President for Programs of the German Marshall Fund of the United States. From 2003 - 2010 he was the executive director for the Balkan Trust for Democracy a project of GMF. He served in 2002-2003 as senior advisor on foreign policy and European integration to the Serbian prime minister – first to Zoran Djindjic and subsequently to Zoran Zivkovic. Prior to his service in the Serbian government, Vejvoda was the executive director of the Belgrade-based Fund for an Open Society from 1998-2002. During the mid-1990's, he

held various academic posts in the United Kingdom and the United States, including a one-year stints as political science professor at both Smith College and Macalester College in the U.S. and a three year fellowship as a researcher at the University of Sussex in England. Vejvoda has published widely on the subjects of democratic transition, totalitarianism, political theory and post-war reconstruction in the Balkans. In addition, he was a prominent figure in the opposition movement in Yugoslavia in the 1990's.

Pier Mario Vello Secretary General, Fondazione Cariplo

Pier Mario Vello is Secretary General of the Fondazione Cariplo and entrusted with its overall reorganisation and positioning as a Knowledge Creating Foundation. Pier Mario serves as a member of the Governing Council of the European Foundation Centre and he is currently a member of the EFC Management Committee and of the Steering Committee of the EFC Research Forum.
